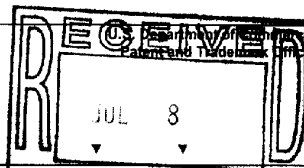


1. The name of the corporation is Dow Jones Telerate, Inc. The name under which the corporation was formed is Telestock, Inc.
2. The certificate of incorporation of said corporation was filed by the Department of State on the 16th day of April, 1969.
3. (a) The certificate of incorporation is amended to change the corporate name of the corporation to DOW JONES MARKETS, INC.
