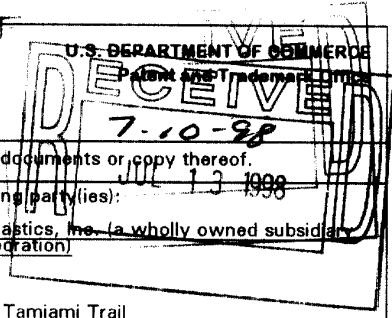

- (g) all claims or causes of action ASSIGNOR has or may have in connection with The Mark(s), including, but not limited

to, the right to sue and recover damages for any and all past infringements of any of The Mark(s).


