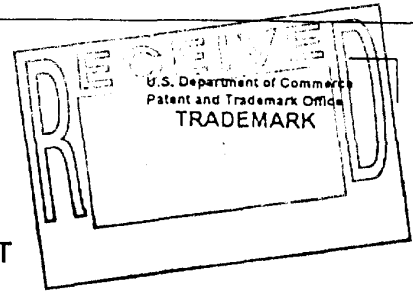

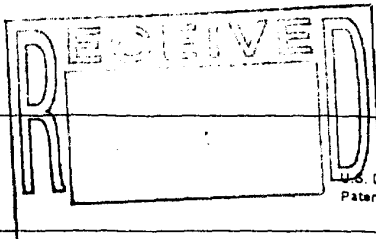


The benefits of this Assignment shall inure to ASSIGNEE and shall be binding upon ASSIGNOR, its assigns, legal representatives and transferees of any nature.
