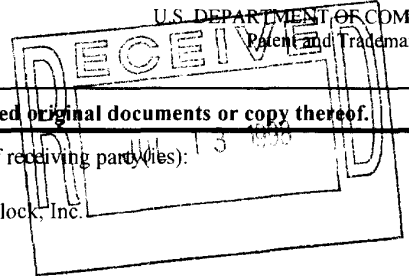

PATENT AND TRADEMARK ASSIGNMENT

This Patent and Trademark Assignment is entered into as of July 31, 1995 by and between Centrax International Corp., a corporation of the State of Texas (hereinafter referred to as "Centrax") and Hunting Interlock, Inc., a corporation of the State of Delaware (hereinafter referred to as "Hunting").

WHEREAS, Centrax is the owner of the entire right, title and interest in and to United States Patent No. 5,352,383 (the "Patent") and the inventions described therein;

WHEREAS, Centrax is the owner of the trademark "MMS" (the "Trademark") and United States Trademark Registration No. 1,476,549 for the mark "MMS" (the "Trademark Registration");

WHEREAS, Centrax and Hunting entered into that certain Asset Purchase Agreement dated July 31, 1995 by which Centrax sold, assigned and transferred to Hunting its entire right, title and interest in and to the Patent, the Trademark and the Trademark Registration; and

WHEREAS, Centrax and Hunting wish to confirm and record Centrax's sale, assignment and transfer to Hunting of Centrax's entire right, title and interest in and to the Patent, the Trademark and the Trademark Registration;

NOW THEREFORE, in consideration of the premises herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Centrax and Hunting, intending to be legally bound, agree as follows:

1. Centrax sells, assigns and transfers unto Hunting, its successors, assigns and legal representatives, all right, title and interest in and to the Patent, the inventions described therein and all reissues, divisions, continuations, continuations-in-part, substitutions, extensions, renewals and reexaminations thereof as well as any patents that may issue in any foreign country that correspond thereto (hereinafter collectively referred to as the "Patent Rights").
2. Centrax sells, assigns and transfers unto Hunting, its successors, assigns and legal representatives, all right, title and interest in and to the Trademark and the Trademark Registration, together with the goodwill of Centrax's business associated with the Trademark (hereinafter collectively referred to as the "Trademark Rights").
3. Centrax further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title and interest in Hunting, its successors, assigns and legal representatives.

4. Centrax hereby further agrees that it will communicate to Hunting, or to its successors, assigns and legal representatives, any facts known to Centrax respecting any improvements to the Patent Rights; and will testify in any legal proceedings (at the expense of Hunting), sign all lawful papers, execute all reissues, divisions, continuations, continuations-in-part, substitutions, extensions, renewals and reexaminations, make all lawful oaths, and generally do everything possible to vest Hunting with title in the Patent Rights and the Trademark Rights and to aid Hunting, its successors, assigns and legal representatives to obtain and enforce proper protection for the Patent Rights and the Trademark Rights in all countries.

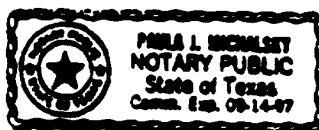
