Pursuant to the provisions of the Kansas General Corporation Code and the Kansas Cooperative Marketing Act, the undersigned cooperative marketing association hereby certifies as follows:

1. Mid-America Dairymen, Inc. is a cooperative marketing association organized and existing under the laws of the State of Kansas.

2. Effective as of September 9, 1997, the Board of Directors of the Association duly adopted a resolution, pursuant to which the Association's Articles of Incorporation would be amended and restated so that, as amended and restated, the Association's Articles of Incorporation shall be and read in their entirety as set forth in the attached Exhibit A, and declared the advisability of such amended and restated Articles of Incorporation.

3. The Board of Directors submitted the amended and restated Articles of Incorporation attached hereto as Exhibit A to the members of the Association, voting through their delegates as permitted by the Kansas Cooperative Marketing Act and as provided in the Association's bylaws, for their approval.

4. Effective as of November 17, 1997, the members of the Association, voting through their delegates, approved the amended and restated Articles of Incorporation attached hereto as Exhibit A. Of the 499 delegates entitled to vote on the amended and restated Articles of Incorporation attached hereto as Exhibit A, 499 delegates voted, and 454 delegates voted FOR and 45 delegates voted AGAINST the amended and restated Articles of Incorporation attached hereto as Exhibit A.

5. The amended and restated Articles of Incorporation were approved by the voting members of the Association (acting through their delegates) in accordance with Section 17-1608 of the Kansas Cooperative Marketing Act.

6. The amended and restated Articles of Incorporation attached hereto as Exhibit A shall be effective as of the date this Certificate of Amendment and Restatement is filed with the Kansas Secretary of State.

**ARTICLES OF INCORPORATION**

**OF**

**DAIRY FARMERS OF AMERICA, INC.,**

**ARTICLE I**

**NAME**

The name of this association shall be DAIRY FARMERS OF AMERICA, INC.

**ARTICLE II**

**ADDRESSES OF RESIDENT OFFICE AND RESIDENT AGENT**

The address of the Association's registered office in Kansas is 534 South Kansas Avenue, Topeka, Shawnee County, Kansas, 66603, and the name of its resident agent at such address is The Corporation Company, Inc.

**ARTICLE III**

**PURPOSES OF THE ASSOCIATION**

The association is formed for the following purposes:

- (a) to engage in any activity in connection with collecting, processing and marketing the products of the Association's members;
- (b) to distribute on a uniform basis the marketing proceeds after paying the expenses and matured liabilities of the Association; and
- (c) to engage in any lawful act or activity for which an Association may be organized under the Kansas Cooperative Marketing Act.

**ARTICLE IV**

**DIRECTORS**

The business and affairs of the Association shall be managed by a board of directors. The number of directors will be as set forth in the bylaws of the Association, but shall be no less than five (5). The term of office of directors shall be as set forth in the bylaws. The bylaws may provide that directors may have more or less than one vote per director in any manner, in which case any reference in the Kansas Cooperative

Marketing Act or other applicable law to a majority or other proportion of directors shall refer to a majority or other proportion of the votes of such directors.

## ARTICLE V

### MEMBERSHIP

(a) The Association is organized without capital stock. The property rights and interest of each member shall be unequal. The property rights and interest of each member shall be determined and fixed in the proportion to the stated value of the retained patronage dividends, per unit retains, and other allocated equity owned by the member to the total retained patronage dividends, per unit retains, and other allocated equity of all members of the Association. New members admitted to membership shall be entitled to share in the property of the Association in accordance with the foregoing general rule.

(b) This Association shall be operated on a cooperative, non-profit basis for the mutual benefit of its members as producers, and membership in the association shall be restricted to producers who patronize the association. To the extent permitted by the Bylaws and the laws of the State of Kansas, members may elect delegates, who shall be entitled to vote in lieu of a vote of the members on all matters requiring a vote of members.

(c) All allocated capital accounts, whether or not evidenced by written notices of allocation or per-unit retain certificates, shall be subordinated to the claims of the Association's creditors and shall not be subject to realization or anticipation.

## ARTICLE VI

### AMENDMENT

(a) The articles of incorporation of the Association may be altered, amended or repealed, or new articles adopted, by an affirmative vote of two thirds (2/3) of the votes entitled to be cast by the entire board of directors then in office and then approved by a vote representing a majority of all the members of the Association. In lieu of a vote representing a majority of all the members of the Association, an amendment may be approved by a vote of two thirds (2/3) of the voting members present and voting at an annual meeting of the Association or a special meeting called for the purpose of voting on the amendment and upon written notice sent by first-class mail to every member at such member's last known post-office address at least ten (10) days prior to such meeting.

(b) The bylaws of the Association may be altered, amended, or repealed, or new bylaws adopted at any time by either (i) an affirmative vote of two thirds (2/3) of the votes entitled to be cast by directors at any meeting of the board of directors, or (ii) by an

affirmative vote of a majority of the votes entitled to be cast by delegates voting at an annual meeting of delegates.

## ARTICLE VII

### PRINCIPAL PLACE OF BUSINESS

The principal place of business for the Association shall be in Kansas City, Missouri.

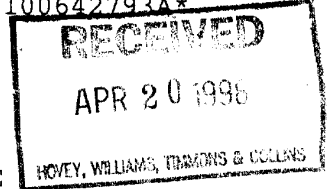

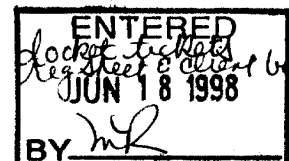
