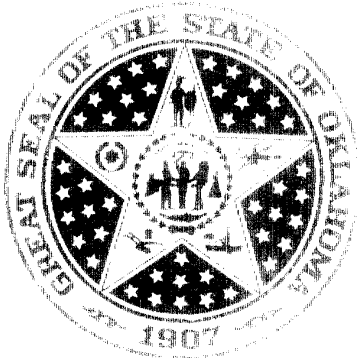

Such amendment was duly adopted in accordance with 18 Okla. Stat. §1077.


