TO THE

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act ("Act"), the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

ARTICLE ONE

The name of the corporation is DRCA Medical Corporation.

ARTICLE TWO

The following amendment to the articles of incorporation was adopted by the shareholders of the corporation owning more than two-thirds (2/3) of the issued and outstanding shares of stock entitled to vote thereon on March 12, 1997. The amendment alters or changes Article I of the Articles of Incorporation of the Corporation by deleting Article I in its entirety and replacing it with the following:

***ARTICLE I.**

The name of the corporation is Integrated Orthopaedics, Inc.*

ARTICLE THREE


The number of shares of the Corporation outstanding at the time of such adoption was 5,286,641 shares of Common Stock and 25,226 shares of the Series A Cumulative Convertible Preferred Stock (the "Preferred Stock"); and all of such shares are entitled to vote thereon. Each share of Common Stock is entitled to one vote and each share of Preferred Stock is entitled to 30.281018 votes with respect to the proposed amendment. The total number of votes outstanding at the time of adoption was 6,050,509.

ARTICLE FOUR

The number of votes in favor of the amendment of the amended Articles of Incorporation was 5,868,752 (5,104,884 represented by votes of holders of 5,104,884 shares of Common Stock and 763,868 votes represented by the votes of the sole holder of all 25,226 shares of the Preferred Stock); and the number of votes against such amendment was 5,400 (all represented by votes of the holders of 5,400 shares of Common Stock).
