**TERMINATION OF SECURITY INTEREST AND RELEASE OF COLLATERAL**


THIS TERMINATION OF SECURITY INTEREST AND RELEASE OF COLLATERAL is made effective as of December 31, 1997 (the "Effective Date") by NationsBank, N.A. (as successor by merger to The Boatmen's National Bank of St. Louis), as agent (herein "Agent") for itself and for each of the other lenders (collectively, the "Lenders") who are parties to that certain Second Amended and Restated Credit Facilities Agreement, dated as of July 19, 1996, as amended (the "Loan Agreement"), by and among the Agent, the Lenders and Pharma Group, Inc. ("Pharma Group") and other borrowers (the "Borrowers").

WHEREAS, PHARMA GROUP granted the Agent for the benefit of the Lenders a security interest in the trademark assets of Pharma Group pursuant to the Second Amended and Restated Trademark Collateral Assignment and Security Agreement, dated as of July 19, 1996, which was filed in the United States Patent and Trademark Office on September 20, 1996 under Reel No. 1524, Frame No. 0717 (the "Assignment"), including without limitation, the trademarks described on Exhibit A attached hereto and incorporated herein by this reference (the "Collateral").

NOW, THEREFORE, the Agent hereby confirms, as of the Effective Date, that the Lenders and the Borrowers have entered into a new agreement whereby the Lenders have agreed to terminate their interest in the Collateral, and the Agent hereby (1) releases, discharges and disclaims, any lien, security interest, pledge and/or assignment created in its favor under the Assignment, or otherwise, which burdens the Collateral, and (2) grants, assigns and conveys, without covenant or warranty, express or implied, all of the Agent's rights, title and interest in the Collateral to Pharma Group.

IN WITNESS WHEREOF, the undersigned has caused this Termination of Security Interest and Release of Collateral to be executed by a duly authorized representative as of the date first written above.
