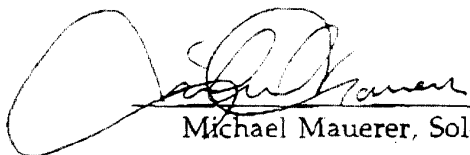
1. Article I of the Corporation's Certificate of Incorporation is amended to read as follows:

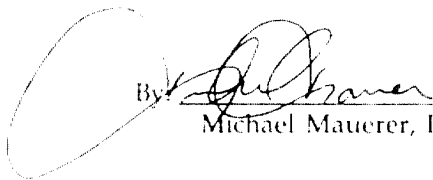

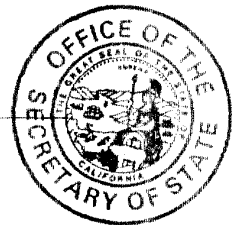
