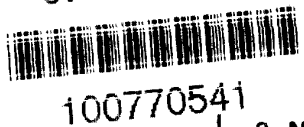

**ASSIGNMENT OF TRADEMARK**

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, said Assignor does hereby sell, assign, set over and transfer to said Assignee, the entire right, title and interest in and to the ASSIGNED TRADEMARK, and any and all U.S. and foreign registrations and applications therefor, including but not limited to U.S. Trademark Application Serial Number 75/341,203, together with the whole of the goodwill pertaining thereto and symbolized thereby, the same and the rights of Assignor to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, at common law and/or to the end of the term or terms for which registration of the ASSIGNED TRADEMARK may be granted, or renewed, as fully and entirely as the same would have been held and enjoyed by assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of the ASSIGNED TRADEMARK with the right to sue for and collect the same for its own use and benefit, and for the use and on behalf of its successors, assigns or other legal representatives.
