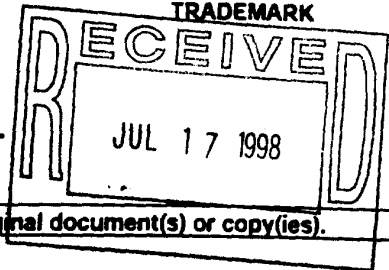

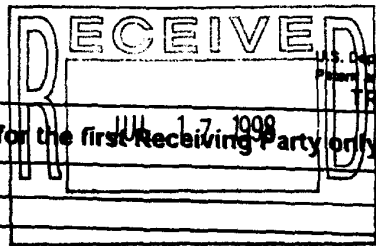

## **TRADEMARK ASSIGNMENT**

THIS ASSIGNMENT, is made by and between W.R. GRACE & CO.-CONN., a Connecticut corporation, having an office at 55 Hayden Avenue, Lexington, Massachusetts 02173 (hereinafter "GRACE") and NATIONAL STARCH AND CHEMICAL INVESTMENT HOLDING CORPORATION, a Delaware corporation, having an office at P.O. Box 7663, Wilmington, Delaware 19803-7663 (hereinafter "ASSIGNEE").

WITNESSETH:

WHEREAS, GRACE is the sole exclusive owner of the trademark registrations in the United States of America and countries foreign thereto described in detail on Schedule A hereto (the "TRADEMARKS"); and

WHEREAS, ASSIGNEE is desirous of acquiring from GRACE the entire right, title and interest in and to and under the said United States and foreign trademark registrations, and of the goodwill of GRACE'S business associated with the TRADEMARKS;

NOW, THEREFORE, to all whom it may concern:

Be it known that for good and valuable consideration paid by ASSIGNEE, the receipt of which is hereby acknowledged, GRACE has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to ASSIGNEE, the TRADEMARKS together with the goodwill of GRACE'S business connected with the use of and symbolized by the TRADEMARKS, the same to be held and enjoyed by ASSIGNEE for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by GRACE if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of the TRADEMARKS with the right to sue for, and collect the same for its own use and behalf, and for the use and on behalf of its successors, assigns or other legal representatives.

GRACE agrees that, at the request of ASSIGNEE, it will make and execute any further assignment of the TRADEMARKS as may be necessary for filing or recording in Patent and/or Trademark Offices of Agencies of the countries listed on Schedule A hereto.

GRACE hereby authorizes and requests the Commissioner of Patents and Trademarks for the United States of America and authorized officials in countries foreign thereto, to issue any and all trademark registrations to ASSIGNEE as assignee of the entire interest in the TRADEMARKS, and hereby covenants that it has the full right to convey the entire interest herein assigned.

IN TESTIMONY WHEREOF, GRACE has caused these presents to be signed by its duly authorized officer, and its corporate seal to be affixed as of the 1<sup>st</sup> day of May, 1997.
