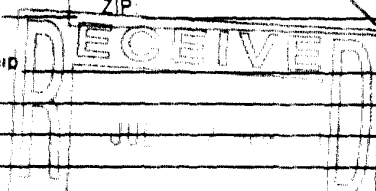

ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK, dated as of June 16, 1998 by Credit Suisse First Boston Corporation ("Assignor"), a Massachusetts corporation with its principal place of business at Eleven Madison Avenue, New York, New York 10010 in favor of Tradeweb LLC, ("Assignee"), a Delaware limited liability company with its principal place of business at One World Trade Center, Suite 5149, New York, New York 10048.

WHEREAS, Assignor is the owner of the trademark TRADEWEB for use in connection with on-line securities brokerage services which is the subject of application No. 75/109, 369 filed on May 24, 1996 in the United States Patent and Trademark Office (the "Trademark") and the goodwill of the business symbolized thereby; and

WHEREAS, Assignee has heretofore been licensed by Assignor to use the Trademark in connection with Assignee's on-line securities brokerage service and Assignee now desires to acquire Assignor's entire right, title and interest in and to such Trademark and goodwill;

- (i) the Trademark including all applications therefor, all registrations which may be granted in respect of such applications, all renewals of such registrations, and all common law rights therein;
- (ii) the goodwill of the business symbolized by the Trademark;
- (iii) all causes of actions, claims and demands or other rights for, or arising from, any infringement, including past infringement, of the Trademark; and
- (iv) all rights corresponding thereto throughout the world.

From time to time after the date hereof, at the request of Assignee, Assignor shall execute and deliver to Assignee such documents and take such other

action as Assignee may reasonably request, at Assignee's expense, in order to consummate more effectively the transactions contemplated hereby


