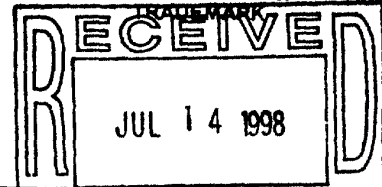

Trademarks

WHEREAS, Elangy Corporation, a New Jersey corporation (herein referred to as "Assignee"), has adopted, used and is using the trademarks listed on the annexed Schedule 1, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"); and


