ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby grants and assigns to Assignee its entire right, title and interest in and to the Marks together with the goodwill of the business in connection with which the Marks are used, and all registrations and applications therefor, including any renewals and extensions of the registrations that may be secured therefor, for the use and enjoyment of Assignee, Assignee's successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made, together with all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.


Assignor authorizes and requests the trademark offices of the appropriate trademark registration issuing authorities to record Assignee as the Assignee and owner of the registrations.
