- (2) PIFCO LIMITED whose registered office is at Pifco House Princess Street Failsworth Manchester M35 OHS ("the Assignee").
- (3) EDWIN DAVID STANLEY KIRKER and STEPHEN PATRICK JENS WADSTED of 20-26 Cursitor Street London EC4A 1HY ("the Administrators")

**RECITALS:**

- (A) The Trade Marks set out in the Schedule hereto ("the Trade Marks") are registered in the name of the Assignor.
- (B) The Administrators were appointed joint administrators of the Assignor by an order of the High Court dated 18 March 1996 as varied by an Order dated 17 June 1996 and an Order dated 15 August 1996 whereby it was ordered that the Administrators should manage the affairs, business and property of the Assignor pursuant to the provisions of Section 8 of the Insolvency Act 1986.
- (C) The parties entered into an agreement dated the 6th day of September 1996 ("the Agreement") for the transfer from the Assignor to the Assignee of certain assets and intellectual property rights including the Trade Marks.

**OPERATIVE PROVISIONS:**



Until 14 November 1996 the Administrators and the Assignor shall at the written request of the Assignee and at the Assignee's expense execute all the documents, papers and authorisations which may be necessary for vesting the rights title and interest assigned hereunder in favour of the Assignee.


