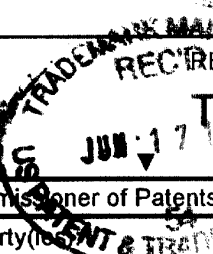

FIRST: The name of the corporation is C4 NETWORK, INC. *UCAS*



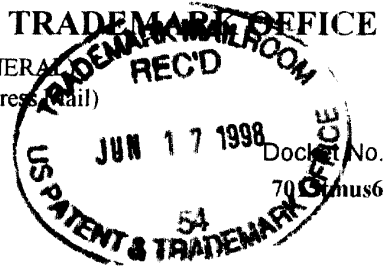
