ASSIGNMENT OF TRADEMARKS**CONFAB, INC.**

WHEREAS, Confab, Inc., a Pennsylvania corporation ("Confab"), Confab Holding Corp., a Delaware corporation ("CHC") and Tyco Group S.a.r.l., a Luxembourg company ("Tyco Luxembourg") entered into an Asset Purchase Agreement dated April 13, 1998 (the "Purchase Agreement") providing for the sale and purchase of substantially all of the assets of Confab to CHC and all of the Trademarks (as defined below) to Tyco Luxembourg (the "Business") [capitalized terms used herein shall have the same meaning as in the Purchase Agreement unless the context indicates otherwise];

WHEREAS, Confab has developed, conceived, acquired or otherwise owns all domestic and foreign trademarks, service marks, trade names, trade dress, labels, logos and all other names and slogans (collectively, "Trademarks") associated with any products or embodying associated goodwill of the Business of Confab related to such products, whether or not registered, and any applications or registrations therefor, and any associated goodwill incident thereto, owned by Confab, including the right to use such Trademarks in regard to products and services in classes not yet utilized but relating to the Business of Confab, specifically including, without limitation, the registrations and applications for registration for the Trademarks identified in Appendix B attached hereto.

WHEREAS, Confab wishes to assign such Trademarks to Tyco Luxembourg, and Tyco Luxembourg wishes to accept the assignment of such Trademarks;

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that for good and valuable consideration, the receipt of which is hereby acknowledged, Confab hereby assigns and transfers to Tyco Luxembourg, its lawful successors and assigns all right, title and interest of Confab in and to said Trademarks and associated goodwill incident thereto.

Confab further covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

Confab further covenants that Confab will, upon Tyco Luxembourg's request, promptly execute and deliver to Tyco Luxembourg or its legal representative any and all papers or instruments required to maintain and enforce said Trademarks which may be necessary or desirable to carry out the purposes hereof.

IN WITNESS WHEREOF, Confab has executed this Assignment of Trademarks on this 13th day of April, 1998.

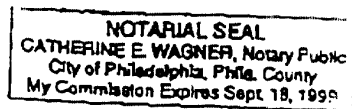
