

AND WHEREAS the Assignor has agreed to assign the Assignee all right title and interests in and to the Trade Mark.


NOW THIS ASSIGNMENT WITNESSES AS FOLLOWS:

3. This Assignment and its terms shall be governed by and construed in accordance with English law and the parties hereby submit to the exclusive jurisdiction of the English courts.


