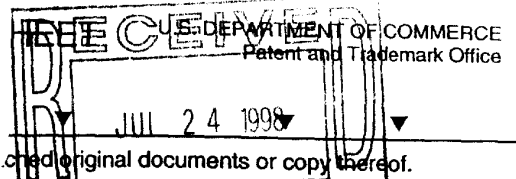

ASSIGNMENT OF UNITED STATES TRADEMARK RIGHTS

WHEREAS, BAKER HUGHES INCORPORATED, (hereinafter referred to as "ASSIGNOR"), a Delaware corporation, having its principal place of business at 3900 Essex Lane, Houston, TX 77027, has adopted, used and is using in its line of business a certain United States trademark;

WHEREAS, ASSIGNOR has the following trademark registration of the United States, hereinafter referred to as "TRADEMARK RIGHTS:"

ASSIGNOR hereby authorizes the Commissioner of Patents and Trademarks of the United States to issue the TRADEMARK RIGHTS to ASSIGNEE in accordance with the terms of this instrument.

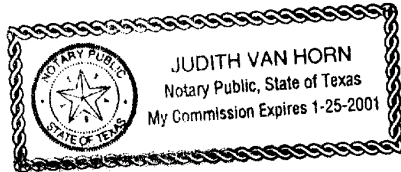
