### ASSIGNMENT

U.S. Repeating Arms Company, Inc., a Massachusetts corporation, having a place of business in New Haven, Connecticut, U.S.A. (hereinafter called "USRAC"), is a licensee of Olin Corporation, a corporation of the State of Virginia, having a place of business in Norwalk, Connecticut, U.S.A., (hereinafter called "Olin") of certain Olin-owned trademarks used by USRAC in the manufacture of Winchester Firearms in the U.S.A. and foreign countries.

During the past several years, a lender to USRAC has recorded, in the Trademark Office, Contingent Assignments of USRAC's Trademark License from Olin, to perfect a security interest in that license in the event of a loan default. Upon payment of the financial arrangement, this lender has recorded an assignment back to USRAC.

These Assignments and Reassignments of the Trademark License have the appearance on the record of an Assignment and Reassignment of the Trademark itself rather than an Assignment and Reassignment of an interest in a Trademark License. These recordings may cause confusion to third parties in searching and determining the Trademark's ownership, which is and has always been in Olin.

In order to clear up any possible confusion as set forth above, USRAC makes the following Assignment to Olin of all Trademarks listed in the attached Appendix "A".

Therefore, effective June 1, 1998, for good and valuable consideration, receipt of which is hereby acknowledged, said USRAC does hereby assign unconditionally to Olin all of its
