

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby transfer and assign unto Assignee all right, title and interest in and to the Trademark and the registration thereof for the United States and throughout the world together with the goodwill of the business associated with the

Trademark. Assignor does also hereby transfer and assign unto Assignee any legal claims arising from past infringement of the Trademark together with the right to sue on and recover for damages and profits for past infringements thereof;


