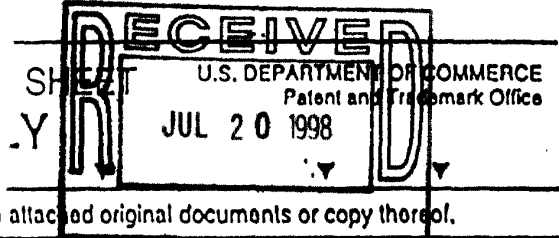

WHEREAS, **Olympia Industrial, Inc.**, a corporation organized under the laws of the State of California is desirous of acquiring said trademark application;



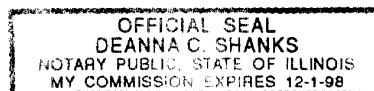
