CONFIRMATORY ASSIGNMENT

WHEREAS, PIED A TERRE LIMITED, a company incorporated in England and Wales whose registered office is at Unit 5G Hewlett House, Havelock Terrace, Battersee, London SW8 4AS, England ("Assignor"), was, as of December 23, 1996, the owner of the trademark PIED A TERRE, now registered in the U.S. Patent and Trademark Office at U.S. Reg. No. 1,834,681 (all such rights referred to as the "Trademark"); and

WHEREAS, NINE WEST DEVELOPMENT CORPORATION, a corporation organized and existing under the laws of the State of Delaware, with offices at Nine West Plaza, 1129 Westchester Avenue, White Plains, State of New York ("Assignee"), acquired said Trademark and all associated goodwill from Assignor as of December 23, 1996; and

WHEREAS, pursuant to a Sale Agreement dated September 26, 1996 Assignor (in administration), acting by its authorized administrator, Peter Dunn (the "Administrator") agreed, inter alia, to assign the Trademark and all associated goodwill to Assignee upon the terms set out in the Sale Agreement and to execute this assignment.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor by its Administrator hereby confirms the assignment to Assignee, as of December 23, 1996, of all rights, title and interest in and to said Trademark,

together with the goodwill of the business symbolized by said Trademark including the above-named registration therefor, and with all claims arising out of or relating to the use of or ownership of said Trademark.
