



TERMINATION OF PATENT AND TRADEMARK SECURITY AGREEMENT

This Termination of Patent and Trademark Security Agreement (this "Termination"), dated as of July 20, 1998, is executed by Greyrock Business Credit, a Division of NationsCredit Commercial Corporation ("GBC"), having a mailing address at 10880 Wilshire Boulevard, Suite 950, Los Angeles, CA 90024, in favor of FAME Information Services, Inc., a Delaware corporation (the "Borrower"), having a mailing address at 325 E. Eisenhower Parkway, Ann Arbor, MI 48108.

RECITALS

WHEREAS, Borrower and Lender entered in a certain Loan and Security Agreement, dated as of May 30, 1997 (the "Loan Agreement"); and

WHEREAS, in connection with the Loan Agreement Borrower and Lender entered into a certain Patent and Trademark Security Agreement dated as of May 30, 1997, (the "Security Agreement"); and

WHEREAS, pursuant to the Security Agreement, Borrower granted to Lender a security interest in certain "Collateral" including certain patents and trademarks; and

WHEREAS, the Security Agreement has been terminated

NOW, THEREFORE, Lender agrees as follows:

1. Lender is executing and delivering this Termination as further evidence of the termination of the Security Agreement
2. Lender claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Security Agreement, and, accordingly, Lender expressly terminates its security interest in the registered trademarks listed on Exhibit A hereto, which security interest was evidenced by the recordation of the Security Agreement with the United States Patent and Trademark Office on June 16, 1997 as to trademarks in Reel/Frame 1599/0859

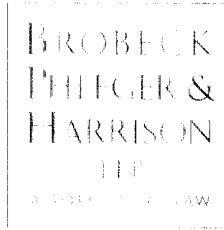


