REAFFIRMATION OF ASSIGNMENT

This Reaffirmation of Assignment is made by Paul Louis Muller, a United States citizen, residing at 481 N.E. 110th Terrace, Miami Shores, Florida 33161 ("Muller").

INTRODUCTION

A. Muller assigned to Jelly Bean Jungle Productions, Inc., and its successors and assigns, certain rights to intellectual property assets related to the Jelly Bean Jungle television series set forth in a Superseding Agreement, Assignment Agreement and Licensing Agreement, all dated January 14, 1995 (the "JBJ Assets").

B. On May 30, Jelly Bean Jungle Productions, Inc. assigned its assets to Donald Kaplan, Assignee for the Benefit of Creditors pursuant to Florida Statute § 727, *et seq.* (the "Assignee").

C. The Assignee has asked Muller to reaffirm the assignment.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge:

1. Muller reaffirms his previous assignment to Jelly Bean Jungle Productions, Inc. of the JBJ Assets in all respects and reaffirms his prior transfer and conveyance of whatever right, title and interest, if any, he has or had, in the JBJ Assets, including trademark rights and associated goodwill to the extent previously assigned.

2. Muller acknowledges the validity of the previous assignments and the rights thereunder; consents, to the extent such consent is necessary, to the Assignee's further
