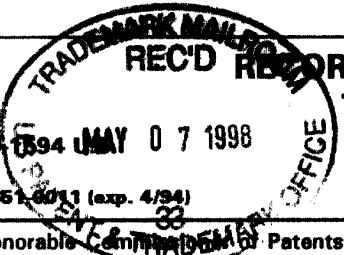

**RELEASE OF SECURITY AGREEMENT**

Agreement entered into this 10 day of April, 1998, between Donald J. Trump ("DJT") on the one hand, and Bankers Trust Company, as agent for the banks party to the Credit Agreement referred to below (in such capacity, together with its successors in such capacity, the "Agent"), on the other.

WHEREAS, DJT, certain banks, and the Agent were parties to a Credit Agreement dated as of August 8, 1990 (as modified and supplemented and in effect from time to time, the "Credit Agreement"), providing for, among other things, the extension of certain credit by said banks to DJT;

WHEREAS, DJT, certain entities related to DJT (collectively, the "DJT Entities"), certain banks and Bankers Trust Company, as Collateral Agent (in such capacity, the "Override Collateral Agent") were parties to an Override Agreement dated as of August 8, 1990 (as modified and supplemented and in effect from time to time, the "Override Agreement"), providing for, among other things, the deferral of certain payments of interest to said lenders by DJT, obligations of DJT and the DJT Entities.

WHEREAS, DJT and Agent entered into a Security Agreement dated August 8, 1990, by which DJT granted Agent a security interest in certain collateral ("Collateral") to induce said banks and the Agent to enter into the Credit Agreement and the Override Agreement and the transactions contemplated thereby;

WHEREAS, the collateral in which a security interest was granted Agent in the August 8, 1990 Security Agreement included, *inter alia*, rights in certain trademarks, trademark applications, and trademark registrations ("Trademark Rights"); and

NOW WHEREFORE, Agent and DJT hereby terminate Agent's security interest in the Collateral as follows:

Agent hereby fully releases all of its right, title, and interest in and to the Trademark Rights.

In furtherance of its release of its security interest in the Trademark Rights, Agent hereby re-assigns (without representation or recourse) to DJT its interest in the Trademark Rights, and any and all interest it may have ever had in the following trademarks:




