To: The Secretary of State of the State of Delaware

Pursuant to Section 252(c) of the Delaware General Corporation Law, the undersigned corporation submits this Certificate of Merger as follows:

1. The constituent corporations are (a) JACK DANIEL'S PROPERTIES, INC., a Delaware corporation, and (b) JDDLMP, INC. (formerly named Jack Daniel Distillery, Lem Motlow, Prop., Inc.), a Kentucky corporation.

2. An agreement of merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with subsection (c) of Section 252 of the Delaware General Corporation Law.

3. The surviving corporation is JACK DANIEL'S PROPERTIES, INC., a Delaware corporation.

4. The certificate of incorporation of the surviving corporation shall be its certificate of incorporation, without any amendment or change as a result of the merger.

5. The executed agreement of merger is on file at the office of the surviving corporation at 4040 Civic Center Drive, San Rafael, California 94904.


6. A copy of the agreement of merger will be furnished by the surviving corporation, on request and without cost, to any stockholder of any constituent corporation.

7. The authorized capital stock of JDDLMP, Inc., which is the only constituent corporation not incorporated in Delaware, is 5,050 shares, each with a par value of \$100.00.
