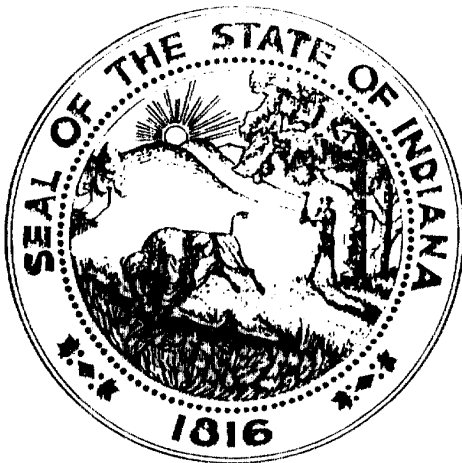
and said Articles of Amendment have been prepared and signed in accordance with the provisions of the Indiana Business Corporation Law, as amended.

AMENDMENT TO THE  
ARTICLES OF INCORPORATION  
OF VELDMAN'S EQUIPMENT, INC.

1. Name. The name of the corporation is VELDMAN'S EQUIPMENT, INC. (the "Corporation").

2. The Amendments. Article I of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read:

Article I. Name.

The name of the Corporation is THE TIRE RACK, INC.

Article III of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read:

Article III. Amount of Capital Stock.

The total number of shares which the Corporation has authority to issue is 1,000,000 shares, no par value per share.

3. Board Action. The Board of Directors by written consent dated April 30, 1998, approved the Amendments set forth above, and directed that they be submitted to a vote of the shareholders of the Corporation.

4. Shareholder Action. On April 30, 1998, the Amendments set forth above were approved, by the unanimous written consent of all the shareholders entitled to vote.
