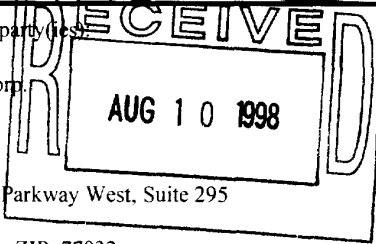

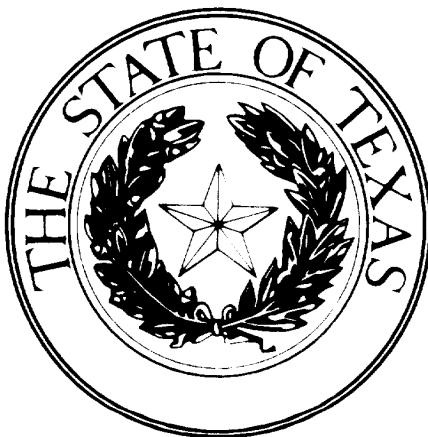

ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is DJ INSPECTION SERVICES, INC.

ARTICLE TWO

This amendment alters Article One of the original Articles of Incorporation and the full text of the altered provision is as follows: The name of the corporation is CENTRAX INTERNATIONAL CORP.

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was 72,938.6355 and the number of shares entitled to vote thereon was 73,938.6355.

ARTICLE FOUR

The number of shares voted for such amendment was 56,892.772 and the number of shares voted against such amendment was zero.
