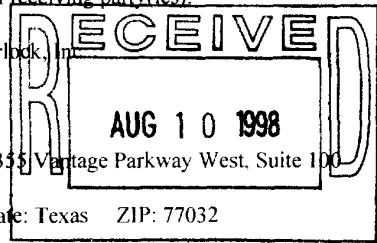

WHEREAS, Centrax owned the entire right, title, and interest in and to following trademark (Exhibit A) which is registered in the United States Patent and Trademark Office:

Centrax does hereby assign unto Hunting, its successors, assigns, and legal representatives, *nunc pro tunc*, all right, title, and interest in and to the above-identified PRESERV-A-THREAD trademark and trademark registration, together with the goodwill of the business symbolized thereto, and the right to sue and recover for any and all past infringement thereof.

2. Centrax further agrees, at Hunting's cost and expense, to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title, and interest in Hunting, its successors, assigns, and legal representatives, and to testify in any legal proceedings related thereto.

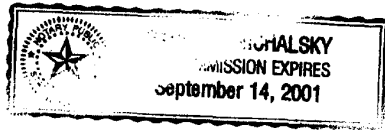

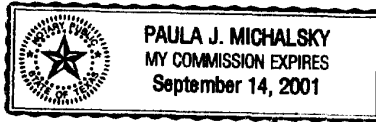
