RELEASE

THIS RELEASE is made by **GFSI, INC. ("GFSI")** and **WINNING WAYS, INC. ("WWI")** in favor of **WORLD TRIATHLON CORPORATION ("WTC")**.

WITNESSETH:

WHEREAS, WWI assigned all its right, title and interest in and to the mark TRIATHALON (Reg. No. 1,437,322), together with the goodwill of the business pertaining to the mark ("the Mark"), to WTC on May 15, 1993, which assignment was recorded on June 21, 1993, at Reel 984, Frame 217 in the United States Patent and Trademark Office ("USPTO"); and


WHEREAS, as part of an overall transaction with GFSI, WWI inadvertently "assigned" the Mark to GFSI on May 12, 1997, which assignment was recorded on May 23, 1997 at Reel 1591, Frame 0577; and

WHEREAS, WWI and GFSI realized that the May 12, 1997 assignment of the Mark to GFSI was in error, inadvertent, and without effect because of the earlier recorded assignment in favor of WTC.


NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, WWI and GFSI jointly and severally hereby (i) acknowledge that the assignment from WWI to WTC, dated February 15, 1993, fully assigned all rights in and to the Mark to WTC; (ii) agree that the assignment dated May 12, 1997 of the Mark from WWI to GFSI was in error, inadvertent without any legal effect; (iii) disclaim and release any and all rights in the Mark; and (iv) represent and warrant that they shall not assert any rights in and to the Mark.
