ASSIGNMENT OF TRADEMARKS

This Assignment of Trademark ("Assignment") is entered into by and between US Telecom Advanced Technology Systems, Inc., a Delaware corporation ("USTATS"), and CSG Systems, Inc., a Delaware corporation, ("CSG").

WHEREAS USTATS has adopted, used, is using and is the owner of the following trademarks:

Collectively, the "Trademarks."

WHEREAS, in accordance with that certain Asset Purchase Agreement dated July 30, 1998, USTATS desires to assign the Trademarks to CSG, and CSG desires to assume all of USTATS' rights therein.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties hereby agree as follows:

- 1. USTATS hereby ASSIGNS and TRANSFERS to CSG all right, title and interest in and to the Trademarks for said marks, together with the good will of the business associated with or symbolized by the Trademarks.
- 2. USTATS further ASSIGNS to CSG all rights to damages or profits due or accrued, arising out of past infringement of the Trademarks or injury to the goodwill associated with or symbolized by the Trademarks, and grants CSG the right to sue for and recover said damages and profits in GGSC's own name.
