SECURITY AGREEMENT TERMINATION AND RELEASE

This Security Agreement Termination and Release (this "Termination") is made as of this 10 day of ~~July~~<sup>August</sup>, 1998, by The Chase Manhattan Bank, a New York banking corporation ("TCMB") and the successor-in-interest to Chemical Bank, a New York banking corporation ("CB"), with an address at 270 Park Avenue, New York, New York 10017, as collateral agent for the "Secured Parties" (as defined in the Security Agreement).

R E C I T A L S

A. Pursuant to the terms of the Intellectual Property Security Agreement dated as of April 6, 1995 (the "Security Agreement"), among CB, Coram Healthcare Corporation ("Coram"), Coram, Inc. ("CI") and all subsidiaries of CI (such subsidiaries together with Coram and CI are collectively referred to as "Borrower"), Borrower granted to CB a security interest in all "Collateral" (as defined in the Security Agreement), including without limitation the trademarks and service marks, trademark and service mark registrations, and trademark and service mark registration applications listed on Exhibit A attached hereto.

B. TCMB is the successor-in-interest to CB.

C. Borrower desires that the Security Agreement be terminated and that TCMB release its security interest in the Collateral.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, TCMB does hereby covenant and agree as follows:

1. The Security Agreement, and TCMB's security interest in the Collateral (including without limitation the trademarks and service marks, trademark and service mark registrations, and trademark and service mark registration applications listed in Exhibit A), is hereby terminated and released.

2. TCMB represents and warrants that it has full power and authority to execute this Termination and to release the security interest in the Collateral.

3. TCMB represents and warrants that it has not assigned or otherwise encumbered its security interest in the Collateral.
