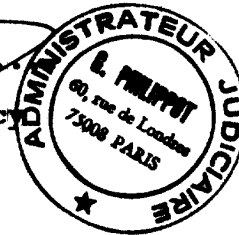

It has also been noted that the identical error appeared on the cover sheet which accompanied the Assignment document which was registered on October 11, 1996.

As result of the errors in the identification of the registration document of the mark "Figure of a bird" a Notice of Recordation, issued by the Assignment Branch of the U.S. Patent

and Trademark Office on December 31, 1996, incorrectly cites the mark TISSUAD (Registration Number 1,366,541) instead of the mark FIGURE OF A BIRD (Registration Number 1,368,541) as one of the marks the ownership of which was to be transferred from SOCIETE PRODUITS DE BEAUTE PARFUMS JEAN D'AVEZE S.A. to SOCIETE AROLI, S.A.

The undersigned respectfully declares that SOCIETE AROLI has never had any interest in obtaining the ownership of the mark TISSUAD, registered at the U.S. Patent and Trademark Office under the number 1,366,541 and erroneously cited in the Assignment document registered on October 11, 1996.

SOCIETE AROLI, S.A. submits herewith the previously registered assignment to be corrected as follows:

- 1. The number of the registration of the mark FIGURE OF A BIRD is to be corrected from 1,366,541 to 1,368,541.
- 2. The registration date of the mark FIGURE OF A TURKLEDOVE (REG. NO.: 820,053) is to be corrected from Dec. 6, 1985 to Dec. 6, 1966.

The SOCIETE PRODUITS DE BEAUTE PARFUMS JEAN D'AVEZE S.A. does not exist any longer and, consequently, cannot provide a corrected assignment document.
