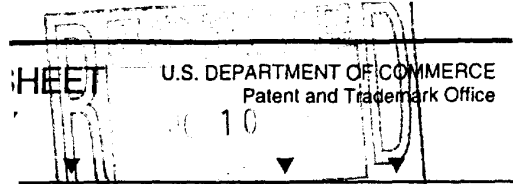

RELEASE OF SECURITY INTEREST

(Patents and Trademarks)

THIS RELEASE OF SECURITY INTEREST is made as of this 23 day of June, 1998, by NATIONSBANK OF GEORGIA, N.A., having an address at 600 Peachtree Street N.E., 21st Floor, Atlanta, Georgia 30308 ("Secured Party"), in favor of EMTEC PRODUCTS CORPORATION, having an address at 140 Olive Street, Elyria, Ohio 44035 and KUHLMAN CORPORATION, having an address at Suite 201, 1 Skidaway Village Walk, Savannah, Georgia 31411 ("Debtors").

WHEREAS, pursuant to a Security Agreement titled "Collateral Assignment of Patents and Trademarks", dated December 15, 1993, Debtors granted and conveyed to Secured Party a lien and security interest in and to Debtors' intangible assets, including patents and trademarks owned by the Debtors;

WHEREAS, for good and valuable consideration Secured Party has agreed to release its security interest, lien and all other rights it acquired from Debtors through the Security Agreement and to reassign to the Debtors any and all rights, title and interest in and to the patents and trademarks included in the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby waives, releases, relinquishes and abandons any and all liens or security interests, and any and all claims of liens or security interests, of any kind or nature, in and to all patents and trademarks identified on Exhibit A attached hereto and made a part hereof, which is a duplicate of Schedule 1 and Schedule 2 attached to the Security Agreement and lists the patent and trademarks subject to the Security Agreement, and Secured Party reassigns to the Debtors any and all rights, title and interest in and to the patents and trademarks listed on the attached Exhibit A, and Secured Party hereby authorizes and directs the Commissioner of the United States Patent and Trademark Office to release the security interest in favor of Secured Party. The foregoing release includes, without limitation, a release of the liens and security interests arising by virtue of the Security Agreement recorded at Reel 1119 Frame 0190, on or about March 8, 1994, in the United States Patent and Trademark Office.

Secured Party agrees to execute such other documents and assurances as may be reasonably necessary to carry out the intent of this Release of Security Interest.

This Release of Security Interest shall be binding upon Secured Party and its successors and assigns.

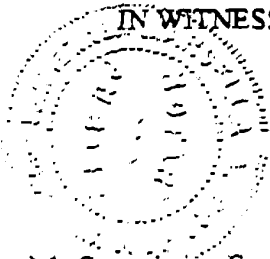
