TRADEMARK ASSIGNMENT

WHEREAS, Donaldson Lufkin & Jenrette, Inc. (the "Assignor"), a corporation organized and existing under the laws of the State of Delaware, has adopted and used and is the sole and exclusive owner of the trademarks and service marks and of the applications and registrations therefor, if any, listed in Schedule A attached hereto and incorporated herein (collectively referred to as the "Trademarks"), and has adopted and used and is the exclusive owner of other trademarks, service marks, and trade names (collectively referred to as the "Other Trademarks"), and of all of the goodwill of the business appurtenant thereto;

WHEREAS, DLJ Long Term Investment Corporation (the "Assignee"), a corporation organized and existing under the laws of the State of Delaware, is acquiring the Trademarks and Other Trademarks from Assignor pursuant to a reorganization of intellectual property assets belonging to Assignor and its subsidiaries undertaken to facilitate the centralized protection, management and control of the rights to and use of the Trademarks and Other Trademarks;

NOW, THEREFORE, in exchange for Eight Hundred (800) shares of Assignee's Class B common stock, the Assignor hereby sells, assigns, transfers, and quitclaims to Assignee, Assignor's entire right, title and interest in and to the Trademarks and the Other Trademarks, together with all of the goodwill of the business appurtenant thereto, and all claims for damages by reason of infringement of the Trademarks and Other Trademarks, with the exclusive right to sue for and collect said damages with respect to the Trademarks and Other Trademarks for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, in all countries throughout the world where Assignor owns, possesses or controls the rights herein being transferred to Assignee, to the full and complete extent of any and all such rights.

AND, Assignor agrees to execute any and all instruments and to perform any and all acts that may be necessary or desirable to fully and expediently effectuate and record this Assignment or perfect the Assignee's rights in the Trademarks and Other Trademarks assigned hereby.

IN TESTIMONY WHEREOF, the Assignor has caused this Assignment to be executed in Chicago, Illinois, by its duly authorized representative, effective nunc pro tunc as of the 2d day of September, 1997.
