
Pursuant to Section 242 of the General Corporation Law of the State of Delaware

Digital Ink Co., a Delaware corporation (hereinafter called "Corporation"), HEREBY CERTIFIES as follows:


- 1. The Corporation was incorporated on November 12, 1993, under the General Corporation Law of the State of Delaware.
