ASSIGNMENT


THIS ASSIGNMENT, dated as of October 22, 1997, is entered into by and between COAST BUSINESS CREDIT, a division of Southern Pacific Bank, a California corporation ("Assignor") and NATIONAL BEDDING COMPANY, an Illinois corporation, dba Serta Mattress Company ("Assignee"), with reference to the following facts:


WHEREAS, pursuant to that certain Loan and Security Agreement, dated July 3, 1996, entered into between American Furnishings Corp., a California corporation (the "Company"), and Assignor, the Company assigned and granted to Assignor a security interest in all its right, title and interest in and to its personal property assets, including the trademarks, service marks and other rights more particularly described in Schedule A attached hereto (collectively, the "Intellectual Property").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby sells, assigns, transfers and delivers to Assignee, and Assignee hereby purchases, all of Assignor's right, title and interest, including all rights of action and damages for past infringement, in and to the Intellectual Property, together with the goodwill of the business in connection with which said Intellectual Property is used or as symbolized thereby, subject to the terms and conditions of the Agreement.
