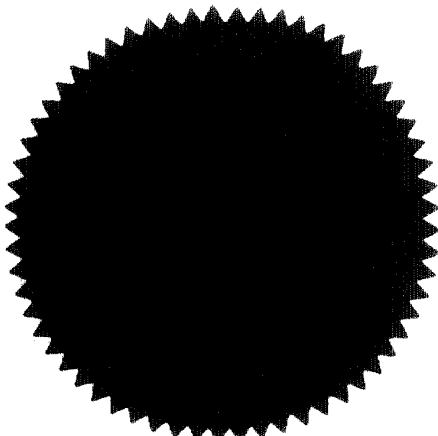
I hereby certify that according to records in this office, CCA Acquisition Corp. was incorporated under the General Laws of this Commonwealth on September 29, 1988.
