## TRADEMARK ASSIGNMENT

**SINY CORP.**, a Wisconsin corporation d/b/a Roller Fabrics ("Roller"), the owner of the trademarks and related applications and registrations set forth in Schedule A attached hereto (the "Trademarks"), being desirous of obtaining a loan from **ROBERT L. HABUSH** ("Lender"), and for other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby, without reservation:

1. To secure repayment of all indebtedness whatsoever of Roller to Lender, assigns and conveys to Lender the entire right, title and interest in and to the Trademarks, in whatsoever countries, and every use or priority right that is or may be predicated upon or arise from the Trademarks; the right to recover for past infringement of the Trademarks and the good will of the business in connection with which the Trademarks are used and which are symbolized by the Trademarks;

2. Authorizes and requests the empowered officials of the relevant government to issue or transfer the Trademarks to Lender, as assignee of the entire right, title and interest therein or otherwise as Lender may direct;

3. Warrants that Roller has not knowingly conveyed to others any right in the Trademarks or any license to use the same except as approved by Lender in writing; and that Roller has the right to assign the same to Lender;

4. Binds Roller's successors, assigns and legal representatives, as well as Roller, to do, upon Lender's request and at Roller's expense, all acts reasonably serving to assure that the Trademarks shall be held and enjoyed by Lender as fully and entirely as the same could have been held and enjoyed by Roller or Roller's successors or assigns if this assignment had not been made; and particularly to execute and deliver to Lender all lawful documents including petitions, oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by Lender; to communicate to Lender all facts known to Roller relating to the Trademarks; and to furnish Lender with any and all documents, in Roller's control or in the control of Roller's successors, assigns or legal representatives which may be useful for establishing the facts surrounding the use and adoption of the Trademarks.
