ASSIGNMENT

This Assignment Agreement is by and between by and between Warnaco Inc., a Delaware corporation with place of business at 90 Park Avenue, New York, NY 10016 and 325 Lafayette Street, Bridgeport, Connecticut ("Assignor") and Courtaulds Textiles (Holdings) Limited, a U.K. corporation with a principal place of business at 13/14 Margaret Street, London, W1A 5DA, England ("Assignee").

WHEREAS, Assignor is the owner of U.S. Trademark Registration No. 1,018,580 for the trademark ULTRA BRA and related goodwill for "brassieres;" and

WHEREAS, Assignee desires to acquire all of Assignor's rights to the mark ULTRA BRA, including Registration No. 1,018,580.
