
FULL RELEASE OF TRADEMARK COLLATERAL
ASSIGNMENT AND SECURITY AGREEMENT

THIS FULL RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT (this "Release") is made and entered into this 20th day of August, 1998, by MERCANTILE BANK NATIONAL ASSOCIATION, a national banking association, formerly known as Mercantile Bank of St. Louis National Association, as Administrative Agent for itself, Deposit Guaranty National Bank, The First National Bank of Chicago, First Union National Bank, LaSalle National Bank, Bank of America National Trust and Savings Association, and any other entity which now or at any time is party to the "Second Amended and Restated Credit Agreement" as a lender (collectively, the "Lenders"), in favor of THE BLETHEN GROUP, formerly known as Blethen Temporaries, Inc., a North Carolina corporation.
