## CONFIRMATORY ASSIGNMENT OF TRADEMARK

**THIS CONFIRMATORY ASSIGNMENT OF TRADEMARK** (this "Assignment"), dated effective as of March 31, 1997, is from GLAXO WELLCOME INC., a North Carolina corporation with an address of Five Moore Drive, Research Triangle Park, NC 27709 ("Assignor") to LEUKOSITE Inc., a corporation with an address of 215 First Street, Cambridge, MA 02142 ("Assignee").

### RECITALS

WHEREAS, the Assignor is the proprietor of the trademark CAMPATH (the "Trademark"), and of related United States Trademark Registration No. 1,767,878 (the "Registration"); and

WHEREAS, Assignor's affiliate, The Wellcome Foundation Limited ("WF"), entered into an Agreement with British Technology Group Limited ("BTG") dated as of March 31, 1997 (the "Agreement"), pursuant to which WF agreed to assign or to procure the assignment of the Trademark and the Registration to BTG's nominee; and

WHEREAS, Assignee is BTG's nominee; and


WHEREAS, as an affiliate of WF and for good and valuable consideration, Assignor assigned to Assignee, pursuant to a Worldwide Trade Mark Assignment, dated March 31, 1997 (the "Worldwide Assignment"), the Trademark, the Registration and all goodwill of the business associated therewith; and

WHEREAS, Assignor and Assignee desire to confirm and record the assignment of the Trademark and related Registration to Assignee.

NOW, THEREFORE, for and in consideration of the foregoing recitals (which are part of this Assignment) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns and conveys to Assignee, effective as of March 31, 1997, all right, title and interest in and to the Trademark and the Registration, together with (1) the goodwill and the business connected with the use of and symbolized by the Trademark and (2) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Trademark. The terms of this Assignment shall be subject to any additional terms and conditions set forth in the Worldwide Assignment.
