

RELEASE AND REASSIGNMENT OF TRADEMARKS

WHEREAS, MELLON BANK, N.A. ("LENDER"), of Mellon Bank Center, 1735 Market Street, Philadelphia, Pennsylvania 19101, is the holder of liens and security interests in all of the present and future right, title and interest of DEBTOR (as defined below) in and to all of the trademarks, service marks, and tradenames listed on Exhibit A attached hereto and incorporated herein by reference and certain rights with respect thereto ("TRADEMARKS"), pursuant to a Trademark Security Agreement recorded in the U.S. Patent and Trademark Office on April 7, 1993 at Reel 0969, Frame 336 ("SECURITY AGREEMENT") by THE REINFORCED EARTH COMPANY, a Delaware corporation ("DEBTOR"), having a mailing address at 2010 Corporate Ridge, Suite 1000, McLean, Virginia 22102, for the benefit of LENDER; and

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, the said LENDER has released and by these presents does hereby release all of its liens and security interests and has reassigned, transferred, and set over, and by these presents does hereby reassign, transfer, and set over unto said DEBTOR, its successors and assigns, all other right, title and interest in, to and under the TRADEMARKS previously granted to LENDER under the SECURITY AGREEMENT.
