This Confirmatory Assignment of Trademark is governed by and made subject to the "Articles of Dissolution" of Powercom-2000, Inc. (under which the corporation was dissolved and all of its assets were transferred to its sole shareholder, Briggs & Stratton Corporation), dated as of June 26, 1998.
