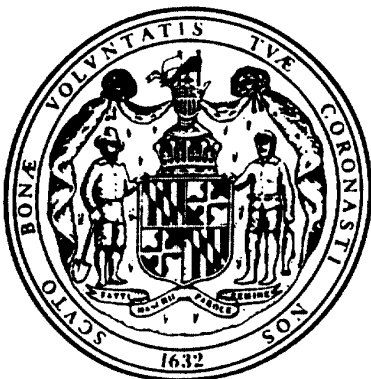

FIRST: The charter of the Corporation is hereby amended by striking out Article 1 of the Articles of Incorporation as heretofore amended, and inserting in lieu thereof the following:

The name of the company shall be Tracor Enterprise Solutions, Inc.
