

## **TRADEMARK RELEASE**

WHEREAS, GRANNY GOOSE FOODS, INC., a California corporation, (the "Borrower"), having its chief executive office at 930 98th Avenue, Oakland, California, 94603, executed a trademark security agreement, in favor of The CIT Group/Credit Finance, Inc.
