The ASSIGNOR further agrees that, upon request by the ASSIGNEE, the ASSIGNOR shall execute and deliver all papers, make all rightful oaths, testify on behalf of the ASSIGNEE and do all other lawful acts necessary to carry out the intent of this Assignment at the ASSIGNEE's expense, as well as provide such other material, information, or assignment as the ASSIGNEE may consider necessary, and this Assignment shall be binding on the parties, their successors and assigns, and all others acting by, through, with or under their direction, and all those in privity therewith.
