CORRECTION OF SECURITY AGREEMENT

THIS CORRECTION OF SECURITY AGREEMENT is made as of the 24<sup>th</sup> day of AUGUST, 1998, among JEFFERSON SMURFIT CORPORATION, a Delaware corporation ("JSC"), JEFFERSON SMURFIT CORPORATION (U.S.), a Delaware corporation (the "Borrower"), each other subsidiary of JSC listed on the signature pages hereof (each such subsidiary, JSC and Borrower individually, a "Guarantor" and a "Grantor" and, collectively, the "Guarantors" and the "Grantors"), and THE CHASE MANHATAN BANK, a New York banking corporation ("Chase") as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties (as defined in that certain PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT dated as of March 24, 1998 ("Security Agreement") mentioned herein below).

WHEREAS, the above-mentioned Security Agreement among the parties hereto was filed and recorded in the records of the Assignment Division of the United States Patent and Trademark Office on April 27, 1998 on Reel 1720 beginning on Frame 0531, whereby the Borrower granted to Chase a security interest in four (4) of its trademarks and the related United States Trademark Registrations; and

WHEREAS, through inadvertence, one of the Trademark Registration Numbers was incorrectly listed and is the first mark listed on the page of that part of Schedule II titled "Smurfit Newsprint Corporation", namely United States Trademark Registration Number 1,729,837 which should have been listed as United States Trademark Registration Number 1,729,337.

NOW THEREFORE, in order to correct the above-mentioned Schedule II to the Security Agreement, the parties hereto agree to delete United States Trademark Registration Number 1,729,837, as listed as the first mark on the page of the aforesaid Schedule II titled "Smurfit Newsprint Corporation" and in its place add 1,729,337.
