ASSIGNMENT FOR SECURITY (TRADEMARKS)

WHEREAS, Reagents Applications, Inc., a California corporation located at 8225 Mercury Court San Diego, CA 92111 (the "Company"), has adopted, used and is using, or, if indicated, has a bona fide intention to use, the mark or marks (the "Marks") shown on Schedule A attached hereto, which are registered in the United States Patent and Trademark Office under the registration numbers shown on such Schedule A next to each of the Marks;

WHEREAS, the Company is obligated to BankBoston, N.A. (the "Bank"), located at 100 Federal Street Boston, Massachusetts 02110, pursuant to (i) a certain Revolving Credit Agreement of even date herewith, among the Bank, the Company, Hemagen Diagnostics, Inc. ("Hemagen") and certain other subsidiaries of Hemagen (the Company, Hemagen and such subsidiaries hereinafter referred as the "Borrowers"), (ii) a Revolving Credit Note of even date herewith, payable to the Bank by the Borrowers; (iii) a Security Agreement of even date herewith, among the Borrowers and the Bank, and (iv) certain other agreements and instruments executed in connection with the foregoing (together, the "Agreements"); and

WHEREAS, pursuant to the Agreements, the Company is granting to the Bank a security interest in and to the Marks, the good will of the business symbolized by the Marks, and the registrations thereof;




